### **PRIVACY POLICY**

# 1. INTRODUCTION:

We Meditorch Technologies Private Limited, a company incorporated under the Indian Companies Act, 1956 with its registered office at Plot D-5, Road No. 20, Marol MIDC, Andheri (East), Mumbai, Maharashtra – 400093 ("Meditorch Technologies"/ "We"/ "our"/ "Us").

We provide services pertaining to a) Educational Hub- Platform: hosting of various development programs, providing advisory assistance through the Mentors registered with Platform, b) Distance Learning Course- consisting of phases such as pre course phase in which knowledge relating to particular subject will be imparted, hands on phase where, training shall be given to User and Post training phase where skill evaluation etc. shall be conducted and c) E- Commerce marketplace: where the Platform shall offer various products which are required by hospitals, clinics or medical practitioners, to Our users ("Users") through Platform, social media pages developed by Us including but not limited to YouTube, Facebook, Instagram, LinkedIn or any other social media ("Social Media") that may come into existence. References to "You", "Users", "Your" shall mean the Users accessing and using the services and the Platform.

We respect the privacy of everyone who visits or uses our Platform. This privacy policy ("Privacy Policy") describes the procedures for collecting, using, and disclosing Your information which You share with Us for availing the Services or accessing the Platform ("Personal Information"). - **ii. "Mentor"** shall mean persons who confirm themselves to be experts in a particular area of medical field registered and listed on the Platform who will be undertaking advisory assistance role for any other User(s).

- **iv. "Faculty"** shall mean medical professionals who confirm their designation and qualification as designated experts in specific medical field who are involved in teaching activity in distance learning course of the Platform.
- **v. "Product(s)"** shall mean surgical equipment and other medical related products required by hospitals, clinics, medical practitioners and offered by the Platform from time to time.
- **vi. "Register"** shall mean registering to the Platform to buy Products and avail Services as provided from time to time.
- **vii.** "Service(s)" shall mean various services offered through variety of mediums including but not limited educational videos of various medical specialities, online/distant learning as well as offline webinars, workshops etc.
- viii. We may also retain Your Personal Information so long as it is necessary to fulfil the purposes for which it was collected (including for purposes of meeting any legal, administrative, accounting, or other reporting requirements). We will ensure that any Personal Information provided by You shall be available for Your review and revisions as and when required and requested.

### 8. COOKIES:

We may set "Cookies" on the use of the Platform by Users.
